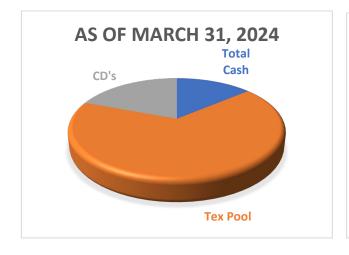

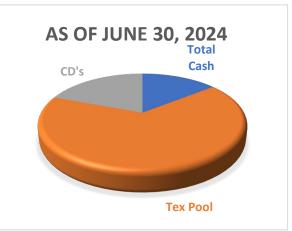

Consideration and action on approving Resolution #EDC 2024-08, amending the 2023/2024 Budget for the Constitution Drive Rebuild Project. **Fred Welch, Executive Director, Copperas Cove EDC.**

Description/Information:

On February 24, 2021, during a Regular Meeting of the CCEDC, a general discussion was held concerning approval for the authorization of expenditures for infrastructure related to the Constitution Drive Drainage and Roadway Improvements project.

This Project was part of the City of Copperas Cove's 2022-2026 Capital Improvement Plan ("CIP") and, at that time, consisted of two components: a) the Drainage portion in the amount of \$442,008 and b) the Street Reconstruction portion in the amount of \$1,597,545 for a total of \$2,039,553. The overall project would improve additional roadway access to The Narrows Business and Technology Park from Highway 190.

On March 24, 2021, the CCEDC Board of Directors approved Resolution # EDC-2021-01 to fund the Constitution Drive reconstruction project, not to exceed \$2,039,553.

In February 2023, the CCEDC received a request to provide additional funding to this project to cover the shortfall and an 8% contingency fee (for unforeseen change fees) for a total amount of \$716,000.

The 2023/2024 Budget was adopted by City Council on August 15, 2023.

The Copperas Cove EDC will need to amend FY 2023/2024 for the transfer of funds from the Reserve Account into the Capital Projects account to support the rebuilding of Constitution Drive.

Budget Shortfall- \$532,883.15 will need to be transferred.

Financial Impact:

Budget Shortfall for Constitution Drive - \$ 532,883.15

Action/Recommendation:

EDC staff requests BOD approve Resolution #EDC 2024-08, to transfer \$532,883.15 from the CCEDC Reserve Account to the Capital Projects account to support the rebuild of the Constitution Drive. This item will be presented to City Council for final approval.

RESOLUTION NO. EDC 2024-08

A RESOLUTION OF THE COPPERAS COVE ECONOMIC DEVELOPMENT CORPORATION APPROVING AND AMENDING THE BUDGET FOR THE COPPERAS COVE ECONOMIC DEVELOPMENT CORPORATION FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2023, AND ENDING ON SEPTEMBER 30, 2024; AND AN EFFECTIVE DATE.

WHEREAS, the Copperas Cove Economic Development Corporation (CCEDC) desires to amend the operating budget of the Economic Development Corporation for the fiscal year October 1, 2023 to September 30, 2024; and

WHEREAS, on March 24, 2021, the CCEDC Board of Directors approved Resolution # EDC-2021-01 to fund the Constitution Drive reconstruction project, not to exceed \$2,039,553.

WHEREAS, in February 2023, the CCEDC received a request to provide additional funding to this project to cover the shortfall and an 8% contingency fee (for unforeseen change fees) for a total amount of \$716,000. The 2023/2024 Budget was adopted by City Council on August 15, 2023.

WHEREAS, the CCEDC needs to amend FY 2023/2024 to approve for the transfer of funds from the Reserve Account into the Capital Projects account to support the rebuilding of Constitution Drive. The Budget Shortfall is (\$532,883.15) which will need to be transferred.

WHEREAS, said Budget Amendments have been submitted to the Economic Development Corporation

Board by the Economic Development Director in accordance with the Bylaws.

WHEREAS, if such Budget Amendments are approved by the Board of Directors, said Budget Amendments will be submitted for ratification to the City Council of the City of Copperas Cove, Texas.

NOW, THEREFORE, BE IT RESOLVED BY THE COPPERAS COVE ECONOMIC DEVELOPMENT CORPORATION:

SECTION I.

The Copperas Cove Economic Development Corporation approves and adopts the amendments to the budget to cover a budget shortfall in the funding of the Constitution Drive reconstruction project considered for the fiscal year of October 1, 2023, to September 30, 2024.

SECTION II.

That the amendments to the budget approved and adopted hereby will be forwarded for consideration and approval by the City Council of the City at their next available meeting.

SECTION III.

That all resolutions for which provision has heretofore been made are hereby expressly repealed if in conflict with the provisions of this resolution.

SECTION IV.

That should any part, portion, or section of this resolution be declared invalid or inoperative or void for any reason by a court of competent jurisdiction, such decision, opinion or judgment shall in no way affect the remaining portions, parts, or sections or parts of section of this resolution, which provisions shall be, remain and continue to be in full force and effect.

SECTION V.

That this resolution shall take effect and be in full force and effect from and after its passage, and approval of the City Council.
