The Copperas Cove EDC is pleased to submit the Unaudited Quarterly Financial Report for the 2nd Quarter Fiscal Year 2022/2023. DonkBuilt Service Exchange performs Bookkeeping, Payroll and Accounts Payable services for the Economic Development Corporation.

As of March 31, 2023, the Economic Development Corporation investment portfolio consisted of bank deposits with Bancorp South and TexPool. Total cash available at month end was \$8,273,528.95. Interest earned during this quarter from TexPool was \$74,078.42, from Bancorp South was \$3,014.15, from 180 day CD \$243.25, from 1 year CD was \$1,144.34, and from 16 month CD was \$2,187.57, totaling \$145.577.89 in interest for the quarter.

We anticipate regular monitoring of the Economic Development Corporation's financial position, and we will continue to provide the City Council and the Board of Directors with information that is useful for making sound policy decisions.

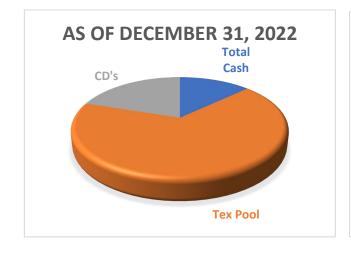

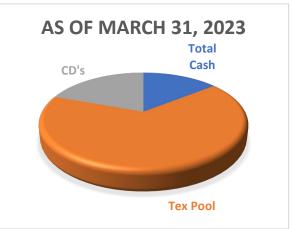
