Total expenditures for the month of March 31, 2021 totaled, \$33,799 which include payroll and disbursements to various vendors. 

Estimate

S&S Trails is submitting an estimate to the Copperas Cove Economic Development Council. The EDC has a section of property where they intend to install a half mile (approximately) natural surface trail. The trail will include a few retaining walls, an overlook with a mural wall, a small bridge and drainage correction and some improved surface.

The natural surface trail is estimated to be 2800 feet long and have a small loop in the middle. The entrance from the east side of the property, due to crossing a bunch of utilities, will require building up instead of digging down to negotiate the 25% slope in the area. One section, where there is no shade will need to be an improved surface to help define the trail and keep the tread surface clear. This is the west end entrance to the dividing lines between the 2 apartment complex sections. There is also a drainage ditch that will need to be rebuilt slightly in order to maintain the drainage needed and a small bridge to be built over it.

Our pricing is for S&S Trails to perform all the labor costs. We will have the EDC purchase materials directly for tax status and local discounts. Cost Estimates below are for budgeting.


